

## Act One Theatre Camp COVID-19

The novel coronavirus, COVID-19, has been declared a worldwide pandemic by the World Health Organization. COVID-19 is extremely contagious and is believed to spread mainly from person-to-person contact. As a result, federal, state, and local governments and federal and state health agencies recommend social distancing and have, in many locations, prohibited the congregation of groups of people.

By signing this agreement, I acknowledge the contagious nature of COVID-19, and voluntarily assume the risk that my child(ren) and I may be exposed to or infected by COVID-19 by participating in Act One Theatre Camp, and that such exposure or infection may result in personal injury, illness, permanent disability, hospitalization, and/or death. I understand that the risk of becoming exposed to or infected by COVID-19 while participating in Act One Theatre Camp may result from the actions, omissions, or negligence of myself and others, including, but not limited to, employees, volunteers, and other program participants and their families.

I voluntarily agree to assume all of the foregoing risks and accept sole responsibility for any injury to my child(ren) or myself including, but not limited to, personal injury, disability, hospitalization, and/or death, illness, damage, loss, claim, liability, or expense of any kind that my child(ren) or I may experience or incur in connection with my child(ren)'s participation in Act One Theatre Camp. On behalf of myslef, and of my child(ren), I hereby release, covenant not to sue, discharge, and hold harmless Act One Theatre Camp and Skewed Evans Productions, its employees, agents, and representatives, of and from the Claims, including all liability, claims, actions, damages, costs, or expenses of any kind arising out of or relating thereto. I understand and agree that this release includes any Claims basd on the actions, omissions, or negligence of Act One Theatre Camp and Skewed Evans Productions, their employees, agents, and representatives, whether a COVID-19 infection occurs before, during, or after participation in any activity organized by Act One Theatre Camp and Skewed Evans Productions.

I acknowledge that I have reviewed the COVID-19 Protocols put in place by Act One Theatre Camp and Skewed Evans Productions, available on thier website at www.actonetheatrecamp.com/covid19, and agree to strictly comply with them at all times. I understand that any failure to comply with these Protocols may result in loss of ability to participate in Act One Theatre Camp activities. Furthermore, I understand that Act One Theatre Camp and Skewed Evans Productions may alter these Protocols at any time, to comply with local, state, and federal guidelines regarding the current state of the pandemic, and that these changes will be made in good faith for the safety and well being of Act One Theatre Camp's and Skewed Evans Productions's participants, employees, and volunteers.

I acknowledge and understand that Act One Theatre Camp and Skewed Evans Productions require that my child(ren) be vaccinated against COVID-19 in order to participate in their programs. I agree to provide proof of this vaccination before my child(ren) will be allowed to participate in their programs.
